

# **Contact Details Change Request**

The Child Online Privacy Protection Act of 1998 requires that anyone under the age of thirteen first receive consent from a parent or guardian before they can participate in any online service that collects, uses, and/or discloses a child's personal information.

#### Same Individual – Updated Information

There are three pieces of identifying information that Encouragemint uses to confirm the identity of the parent or guardian granting consent. Specifically we look at your name, email address, and signature. In order to release information or update your contact details all three pieces of information must be confirmed.

If you do not remember who provided the initial consent, please contact us by email with your name and the child's name and date of birth. We will email you back with the name of the individual or individuals who initially provided consent.

If your name or signature has changed since completing the initial consent form, you must use the original information in completing Part A below. If you have multiple email addresses and do not remember which one you submitted to us, we suggest you note all of them below. While we may confirm that you have the correct email address we will not otherwise provide it to you.

No supporting documentation is required to change your email address, nor is any required to simply change your signature. If however you are changing your name, and correspondingly your signature as well, please provide supporting documentation of the name change. This may include a marriage certificate, divorce papers, a court provided legal change of name, etc. Certified copies are not required.

#### Addition or Removal of Consent Provider

All information from the original provider of consent must match the information provided in the original form. If any of that information has changed please complete this form twice; once to update the original provider of consent's information and again to add or remove a second consenting parent/guardian.

If you would like to add a second consenting parent/guardian, simply complete the information below. If you would like to remove someone you must provide a reason and supportive documentation. Supporting documentation may include a copy of a restraining order, a court ordered change in custody, adoption papers, a death certificate, evidence of a child endangerment conviction, or other similar documentation. We will not remove a consenting parent/guardian due to marital separation or divorce where there is not another reason for the request. Supporting documentation does not need to be provided in the form of certified copies.
